THIS AGREEMENT IS FOR BROADCASTERS THAT ARE ON BLOOD BOUGHT RADIO. ALL BROADCASTERS MUST ABIDE BY THE GUIDELINES AND STANDARDS OF BLOOD BOUGHT RADIO. (SEE GUIDELINES AND STANDARDS)

ALL BROADCASTERS OF BLOOD BOUGHT RADIO WILL NEED TO PROVIDE SPECIFIC AIRTIMES, LENGTH OF BROADCAST AND DAY(S) OF BROADCAST FOR DESIRED SLOT, (IF AVAILABLE). ALL BROADCASTS **MUST** BE PRERECORDED IN MP3 FORMAT, (RADIO QUALITY REQUIRED)! BROADCASTERS WILL BE ASKED TO PROVIDE ARTWORK, LINKS OF WEBSITE AND/OR SOCIAL MEDIA SITES. ONCE AGREEMENT IS SIGNED AND OFFICIAL, BROADCASTERS WILL BE ASKED TO SEND IN A RADIO "DROP" (IN RADIO READY MP3 FORMAT) TO BE ADDED IN OUR DAILY ROTATION FOR ADVERTISING PURPOSES OF BROADCAST.

BROADCASTERS WILL BE REQUIRED TO ASSIST IN THE FINANCIAL STABILITY OF BLOOD BOUGHT RADIO BY CONTRIBUTING A \$25 MONTHLY DUE. THIS DUE IS FOR THE ASSURANCE OF BROADCAST & STABILTY OF B.B.R. EVERY MONTH. THIS CONTRIBUTION IS DUE EACH MONTH BEFORE THE AIRING OF ANY BROADCAST. FAILURE OF PAYMENT WILL RESULT IN THE SUSPENSION OF BROADCAST.

GUIDELINES AND STANDARDS

BLOOD BOUGHT RADIO is an internet-based radio station geared to represent true Holy Hip-Hop and R&B in it's purest form. Ministering the Word of God through music fashioned in an art form that reaches out toward the global urban generation of all ages. Blood Bought Radio (B.B.R.), offers a platform for artists to exhibit their gift from God while glorifying the Kingdom and edifying the Church!

Blood Bought Radio will not air any artist that are not walking out the call of God in their life. B.B.R. supports artists that have a call and will to honor God in their everyday lives, not just in their music. We don't want to give those who follow and support our station the wrong impression concerning the conduct of our walk in Christ! There will be no room for compromise! We worship our Lord in Spirit and in Truth and require all those that are aired on the station to do so.

In addition, Broadcasters must also live in a Christlike manner with material that reflects Christ and His word!! **No derogatory language, racial slurs or sexual content will be tolerated by broadcasters or artists that are aired by broadcaster!! Any violation of these terms will result in an automatic termination of Blood Bought Radio Broadcaster's Agreement!!**

Blood Bought Radio will not air any advertisement or material of secular artists!! However broadcasters can air advertisement of businesses of taste and/or church/outreach events.

According to Licensing, broadcasters can not air the same artist or song more the twice in a row!! Such actions will be in violation to our licensing agreement.

IN ADDITION, ALL BROADCASTERS WILL BE GIVEN THE OPPORTUNITY TO EARN FINANCIAL COMPENSATION BY DIRECTING POTENTIAL ADVERTISERS, ARTISTS, PROMOTERS & SPONSERS TO OUR SPONSORSHIP PACKAGES LOCATED UNDER OUR OPPORTUNITES (SPONSORSHIP) PAGE ON OUR WEBSITE. ONCE THERE, BROADCASTERS WILL FIND ALL OF THE PROVIDED OPPORTUNITES THAT BLOOD BOUGHT RADIO OFFERS. BROADCASTERS WILL RECEIVE 50% OF ANY CONFIRMED SPONSORSHIP. ALL PAYMENTS **MUST** BE SENT TO BLOODBROUGHTRADIOBROADCAST@GMAIL.COM VIA PAYPAL. FOR COMPENSATION PAYMENTS, BROADCASTERS MUST PROVIDE A PAYPAL TO RECEIVE PAYMENTS FROM CONFIRMED SPONSORSHIPS. ALL BROADCASTERS ARE ENCOURAGED TO PRESENT SPONSORSHIP OPPORTUNITES TO AS MANY POTENTIAL SPONSORS AS POSSIBLE. (THE MORE YOU PRESENT, THE MORE OPPORTUNITY YOU HAVE TO GAIN FINANCIAL COMPENSATION).

ABSOLUTELY NO UNAUTHORIZED ADVERTISING WILL BE PERMITTED WITHOUT CONSENT!!

THE BLOOD BOUGHT RADIO BROADCASTER'S AGREEMENT IS STRICTLY VOLUNTARY.

BROADCASTERS ARE FREE TO WITHDRAW FROM THIS AGREEMENT AT ANYTIME WITHOUT LEGAL PENALTY. IF ANY BROADCASTER DESIRES TO TERMINATE THEIR BLOOD BOUGHT RADIO BROADCASTER'S AGREEMENT, BLOOD BOUGHT RADIO WOULD ASK THAT BROADCASTER GIVE TWO (2) WEEKS NOTICE OF TERMINATION PRIOR TO DEPARTURE. IF THE BROADCASTER'S VOLUNTARY TERMINATION OF AGREEMENT IS AFTER BROADCASTER'S PAYMENT OF CONTRIBUTION, THE BROADCASTER'S BROADCAST WILL CONTINUE TO AIR FOR THE DURATION OF THE MONTH (UNLESS TOLD OTHERWISE). UNFORTUNENATELY, THERE WILL BE NO REFUND OF MONTHLY DUES AFTER IT HAS BEEN RECEIVED. ALL BROADCASTS MUST BE APPROVED BEFORE AIRING. BROADCASTERS ARE RESPONSIBLE FOR SENDING IN ALL BROADCASTS IN 48 HOURS BEFORE SCHEDULED TIME AND DAY BEFORE BROADCASTS ARE AIRED. ONCE AGAIN, BROADCASTS MUST BE PRERECORED AND IN MP3 FORMAT TO BE IN COMPLIANCE WITH OUR SERVER.
